

# Moving Expenses

Always keep your receipts or record of the trip in case CRA or Quebec ask for them in the future

## Requirements

Eligible moving expenses can be claimed if you moved to a new home to work or run a business at a new location or if you moved to be a student in full-time attendance in a post-secondary program. To qualify, your new home must be **at least 40 Kilometers** (by the shortest usual public route) **closer** to your new work or school
